- a) The Board of Education approves the North Merrick UFSD June 30, 2018, Reserve Plan for use of Reserves and Fund Balance for the 2017/18 school year.
- b) The Board of Education authorizes a transfer of \$2,950 to fund balance of the General Fund from the unemployment insurance payment reserve fund as of June 30, 2018.
- c) The Board of Education authorizes a transfer of \$522,521 to fund balance of the General Fund from the Retirement Contribution Reserve as of June 30, 2018.
- d) The Board of Education authorizes a transfer of \$420,839 to fund balance of the General Fund from the Reserve for employee benefit accrued liability as of June 30, 2018.
- e) The Board of Education authorizes a transfer of \$400,000 from the fund balance of the General Fund to the Retirement Contribution Reserve as of June 30, 2018.
- f) The Board of Education authorizes a transfer of \$174,000 from the fund balance of the General Fund to the Reserve for employee benefit accrued liability as of June 30, 2018.
